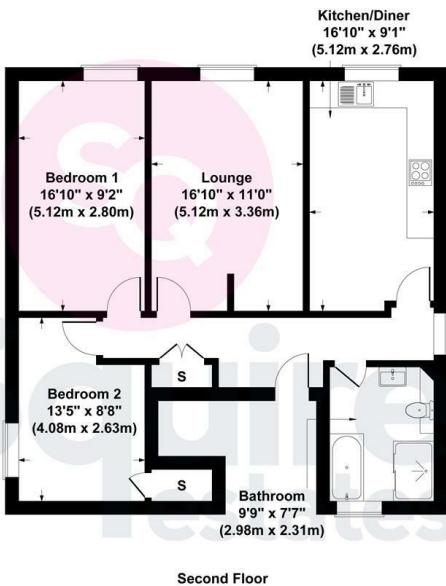

Gross Internal Area 829 sq ft / 77 sq metres



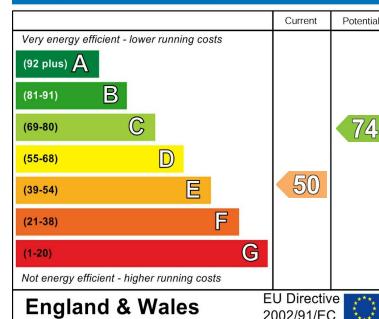
